2. Scope of Work:

- a) Development of web application Online Net Metering Agreements for solar consumers.
- b) Verification of Consumer through registration number & mobile number.
- c) Tracking of application process.
- d) Viewing consumer details with OTP authentication
- e) Verification of "No Due" status through with API integration
- Visitors of the website shall be able to view/download documents/pictures/images uploaded by concerned officials through Admin panel.
- g) Website should work seamlessly on any device with proper display settings
- h) Admin panel should have full control over the content of the entire website
- Should have a page where public can send feedback.
- j) Misc requirement from time to time.
- 3. Training of MSPDCL employees: The service provider shall provide training to MSPDCL employees on the handling and operation of the application. Service provider shall also provide specialized training on how to maintain the codebase in the future.
- Support: The service provider shall support MSPDCL to ensure the correct functioning and compliance to requirements for a period of 1 year from the date of delivery of project.
- Penalty: In case the delivery is not completed within the stipulated delivery period, penalty shall be imposed @ 1/2% per week subject to a maximum of 5% of such portion of the contract value which remain undelivered or delivered late. In any case, the delivery shall not be delayed by more than 2(two) calendar months from the scheduled delivery period and if so delayed, MSPDCL reserves the right to cancel this supply order without any formal intimation. The imposition of penalty is however subjected to Force Majeure condition.
- Force Majeure Condition: The force majeure conditions shall be such acts of God, acts of public enemy, Fire, Flood, Epidemic etc. The supplier shall however notify the department in writing of such within 10(ten) days from the date of happening. Similarly, if the materials could not be delivered in time, formal intimation explaining the reason for inability to deliver on time shall be submitted to
